Dear Milton Residents.

The citizens of Milton care very much about our community and specifically our schools and how they are performing. That includes the citizens, parents, grandparents, and students who are active in VPACT (Vermont Parents Against Critical Theory).

The reason this organization formed was in response to disparate treatment of students, sometimes based on race, or other characteristics, occurring in Millon schools. We all want a school policy that will promote fairness, acceptance and tolerance and teach children to act with kindness. Critical Theory does not do that in our view and further highlights our differences rather than our commonalities. Critical Theory is fundamentally divisive. Find out more about this at VPACT.org

VPACT has grown organically as parents realized they were not alone in their concerns and shared their experiences. Many feel academic instruction has been diluted by the social justice curriculum and this has resulted in declining test scores. Milton schools rank 204-221 out of 279 schools in Vermont with math and reading proficiency rates of 20-24% and ranks in the 21-37 out of 55 high schools with proficiency at 50-54%. See for yourself at https://www.publicschoolreview.com/math-proficiency-stats/vermont. The current FY24 proposed school budget, if approved, will result in education spending of \$19,480.16 per equalized pupil. This is roughly \$2,000.00 more a year per equalized pupil than last year. Currently, less than 1 out of 4 students can do grade level math.

Students are also suffering because of disciplinary problems preventing them from learning. We understand this is a huge challenge for educators; but is the administration and the school board doing all they can to support the staff to maintain classroom order? We know that Critical Theory is adding to classroom chaos. Has your child been harassed by another student, and nothing happens to stop it? That's heartbreaking for a parent, damaging for a harassed child and the wrong incentive for a child who is misbehaving.

In order to fix problems, you must recognize them, then find solutions. VPACT was created to do just that.

Electing new School Board members who truly care, such as Alison Duquette and Nick Smith is an important step in fixing the current issues within Milton's Schools. Let's move forward together with better ideas and strong representatives who will achieve the improvements that must be made for all our kids' success.
